RESOLUTION NO. SP-**7433**, S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A USUFRUCT AGREEMENT WITH THE DEPARTMENT OF EDUCATION REPRESENTED BY ITS SECRETARY LEONOR MAGTOLIS BRIONES, FOR THE UTILIZATION BY THE SCHOOLS DIVISION OFFICE OF QUEZON CITY OF A PORTION OF A QUEZON CITY GOVERNMENT PROPERTY LOCATED IN BARANGAY TALIPAPA, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBER 37513, 37516, 37517, 104378, 37515, 102397, 37514, 104402, 37518, 104007, 102753, 102754, 127847, 131149, 131150, 131151, 129351, 116180, 138127, AND 165631, CONTAINING AN AREA OF EIGHTEEN THOUSAND FOUR HUNDRED FIFTY THREE (18,453) SQUARE METERS, MORE OR LESS AS A SITE FOR THE ESTABLISHMENT OF TALIPAPA SENIOR HIGH SCHOOL.

WHEREAS, with the full implementation of the Senior High School program of the Department of Education, it is imperative that additional schools be established;

WHEREAS, Honorable Jose Christopher Y. Belmonte, Representative, Sixth District of Quezon City filed House Bill No. 7060 entitled: "An Act Establishing a Senior High School in Barangay Talipapa, Quezon City, Metro Manila to be known as Talipapa Senior High School, and Appropriating Funds Therefor";

WHEREAS, the Quezon City Government is the owner of a parcel of land with an area of eighteen thousand four hundred fifty three (18,453) square meters more or less including any and all improvements existing thereon, registered and covered by Transfer Certificates Title Number 37513, 37516, 37517, 104378, 37515, 102397, 37514, 104402, 37518, 104007, 102753, 102754, 127847, 131149, 131150, 131151, 129351, 116180, 138127, and 165631 of the Registry of Deeds of Quezon City;

WHEREAS, the Quezon City Government offered to the Department of Education the use of abovementioned property as a site for the establishment of Talipapa Senior High School;

WHEREAS, the term of the usufruct shall be for a period of twenty-five (25) years and renewable for another twenty-five (25) years at the option of the Quezon City Government;

WHEREAS, the Department of Education shall, on its account, construct the building facilities, structures, and other improvements on the subject property and maintain the same in accordance with ordinances and national laws on safety and environmental protection, maintenance and preservation;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned";


WHEREAS, Section 455, (b)(1)(vi) of Republic Act No. 7160, likewise states that "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance".




NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Usufruct Agreement with the Department of Education represented by its Secretary Leonor Magtolis Briones, for the utilization by the Schools Division Office of Quezon City of a portion of a Quezon City Government property located in Barangay Talipapa, covered by Transfer Certificates of Title Number 37513, 37516, 37517, 104378, 37515, 102397, 37514, 104402, 37518, 104007, 102753, 102754, 127847, 131149, 131150, 131151, 129351, 116180, 138127, and 165631 containing an area of eighteen thousand four hundred fifty three (18,453) square meters more or less, as a site for the establishment of Talipapa Senior High School.
