*WHEREAS, Brazilian Jiu-jitsu was created by Helio Gracie in the 1950s to address the need of providing self-defense for those who were not physically gifted with strength by applying proper techniques of using the right leverage to overcome bigger adversities. This martial art espouses joint locks and chokes to subdue an opponent, hence called the "gentle art";*

*WHEREAS, the Asian Sport Jiu-Jitsu Federation (ASJFF) is an international sports organization which holds Jiu-Jitsu tournaments internationally across Asia and within the Philippines, particularly in Cebu, that is participated by high-level jiu-jitsu competitors locally and overseas based. This is the first time that this organization held a Jiu-jitsu tournament in Luzon particularly in Tarlac City last February 17, 2018;*




NOW, THEREFORE,


