HONORABLE CITY MAYOR, RESOLUTION URGING THE HERBERT M. BAUTISTA, TO PURCHASE BASIC FAMILY MEAL FOR THE BASIC FAMILY MEAL ENRICHMENT PROGRAM TO BE PROVIDED/DISTRIBUTED TO THE INDIGENT FAMILIES OF THIS CITY.

WHEREAS, Section 1, Article XV, of the 1987 Constitution provides that "The State recognizes the Filipino Family as the foundation of the nation. Accordingly, it shall strengthen its solidarity and actively promotes its total development;

WHEREAS, the City Government, pursuant to Ordinance No. SP-2180, S-2011, also known as "An Ordinance enacting the Quezon City Children's Code of 2012", declared that it is the policy of the Quezon City Government that the rights of children to their survival, protection, participation and development must be given high priority; it will work for the respect of the role of the family in providing for the needs of children and will support the efforts of parents, other child care and development workers, non-government organizations (NGO's) and communities in nurturing and caring for children, from infancy including the early stages of childhood to adolescence;

WHEREAS, Ordinance No. NC-168, S-90, approved last November 2, 1990, established the Social Services Development Department (SSDD), with its primary objective to uplift the socio-economic status of the Quezon City residents and promote self-sufficiency and self-reliance among the constituency;

WHEREAS, SSDD is working for the socially, economically and physically disadvantaged constituents to provide them the opportunities needed to develop self-reliance and become participating members of the community;

WHEREAS, SSDD is committed to formulate and implement comprehensive programs and services to develop individuals, groups and communities to be self-reliant. It aims to uplift the general well-being of the socially disadvantaged and vulnerable groups, individuals and communities to be self-reliant and productive members of the community;

WHEREAS, more or less, 58,000 families belonging to the disadvantaged groups were surveyed and assessed to determine their economic/psycho-social situation to be considered as clients;

WHEREAS, the City is equipped with Family Welfare Programs that aims to provide the families with basic services that can alleviate their current situation. One of this program is the "Basic Family Meal Enrichment Program" that aims to distribute basic family meal packages to the indigent families.
