RESOLUTION NO. SP- **7455**, S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, QUEZON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL MAYOR OF TERESA, RIZAL, HONORABLE RAUL S. PALINO, FOR THE GRANTING OF THE FINANCIAL ASSISTANCE FUND TO THE MUNICIPAL GOVERNMENT OF TERESA IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), EARMARKED TO COVER THE EXPENSES FOR THE STREET LIGHTING AND IMPROVEMENT OF THE SERVICE ROAD OF NATIONAL HOUSING AUTHORITY (NHA) RESETTLEMENT SITES IN TERESA AND MORONG, PROVINCE OF RIZAL, AS WELL AS FOR THE PURCHASE OF A MINI DUMP TRUCK AND AN AMBULANCE.

WHEREAS, Local Government Unit of Quezon City (LGU-QC) has been relocating its informal settler families (ISFs) to NHA Resettlement Site Authority (NHA) relocated in the Municipality of Teresa, Rizal;

WHEREAS, the Local Government Unit of Teresa (LGU-Teresa) has agreed to receive the ISFs-relocattees from Quezon City to NHA Resettlement Site situated within its territorial jurisdiction, however, due to its limited resources and budgetary constraints to provide and sustain the essential needs of the relocatees, it has solicited support from the sending LGU;

WHEREAS, LGU-QC is well aware that to live a humane life at the relocation site, the resettled ISFs must have basic needs such as education, health, permanent utility services, affordable transportation, peace and order and livelihood programs;

WHEREAS, pending the availability and provision of the post relocation assistances and services mandates under the resettlement programs of the National Government, LGU-QC is agreeable in providing financial support to LGU-Teresa;


WHEREAS, LGU-Teresa, through a letter from its Municipal Mayor, Honorable Raul S. Palino, dated January 31, 2018, has requested for financial support assistance from the LGU-QC to cover the expenses for various items stipulated in the said letter, which among other includes street lighting and improvement of the only service road leading to the NHA Resettlement Sites in Teresa and Morong, Rizal, and which stretch of the service road is located within the territorial jurisdiction of Teresa, Rizal, a copy of the letter is hereto attached and made integral part of this instrument;

WHEREAS, LGU-QC has agreed to allocate a financial assistance fund of Php10,000,000.00 to LGU-Teresa earmarked to cover the expenses for the various items/requirements mentioned in the letter request of the Mayor of Teresa, Rizal;

WHEREAS, the granting of the said financial assistance fund will directly benefit not only the ISFs-Relocatees from Quezon City resettled to Teresa, Rizal but the ISFs -Relocatees in Morong-Rizal;

WHEREAS, the parties have mutually agrees to enter into a Memorandum of Agreement for the granting of the financial support assistance, earmarked for the various items/requirements for ISFs-Relocatees from Quezon City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code" of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

Palino, for the granting of the financial assistance fund to the Municipal Government of Teresa in the amount of Ten Million Pesos (Php10,000,000.00), earmarked to cover the expenses for the street lighting and improvement of the service road of National Housing Authority (NHA) Resettlement Sites in Teresa and Morong, Province of Rizal, as well as for the purchase of a Mini Dump Truck and an Ambulance.


