RESOLUTION NO. SP. 7456, S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, QUEZON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL MAYOR OF MORONG, HONORABLE ARMANDO D.G. SAN JUAN, FOR THE GRANTING OF ADDITIONAL FINANCIAL ASSISTANCE FUND TO THE MUNICIPAL GOVERNMENT OF MORONG, IN THE AMOUNT OF SEVEN MILLION PESOS (PHP7,000,000.00), EARMARKED TO COVER THE EXPENSES FOR THE EDUCATION RELATED REQUIREMENTS OF THE ISFs-RELOCATEES FROM QUEZON CITY RESETTLED TO NATIONAL HOUSING AUTHORITY (NHA) RESETTLEMENT SITE IN THE MUNICIPALITY OF MORONG, PROVINCE OF RIZAL.

WHEREAS, the Local Government Unit of Quezon City (LGU-QC) has been relocating its informal settler families (ISFs) in NHA Resettlement Site located in Sitio Talaga, Morong, Rizal;

WHEREAS, the Local Government Unit of Morong (LGU-Morong) has agreed to receive the ISFs-relocatees from Quezon City to NHA Resettlement Site situated within its territorial jurisdiction, however, due to its limited resources and budgetary constraints to provide and sustain the essential needs of the relocatees, it has solicited support from the sending LGU;

WHEREAS, LGU-QC is well aware that to live a humane life at the relocation site, the resettled ISFs must have access to basic needs such as education, health, permanent utility services, affordable transportation, peace and order and livelihood programs;

WHEREAS, pending the availability and provision of post relocation assistances and services mandated under the resettlement program of the national government, LGU-QC is agreeable in providing financial support assistance to LGU-Morong;

WHEREAS, in 2017, LGU-QC had allocated and provided a financial assistance fund of Php20,000,000.00 to LGU-Morong, intended to cover the expenses for the improvement of resettlement sites, acquisition of lots for the construction of social infrastructure facilities such as multi-purpose centers, acquisition of service vehicles and garbage truck, skills training, livelihood as well as education and health services programs;

WHEREAS, by virtue of a Memorandum of Agreement (MOA), entered into in 2017 by and among LGU-QC, NHA and LGU-Morong, for the transfer of the above-cited financial assistance fund, all available housing units and those that are to be constructed in NHA Resettlement Site in Sitio Talaga, Morong, Rizal, shall be exclusively allocated to priority ISFs for relocation from Quezon City;

WHEREAS, LGU-Morong, through an endorsement letter by Municipal Mayor, Honorable Armando D.G. San Juan dated January 23, 2018, has requested additional fund intended for various items, a copy of the letter and attached documents are hereto attached and made integral part of this instrument;

WHEREAS, LGU-QC has agreed to allocate an additional financial assistance fund of Php7,000,000.00 to LGU-Morong, earmarked to cover the expenses for the education related requirements of the ISFs-Relocatees from Quezon City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Paplungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, Quezon City, to enter into a Memorandum of Agreement (MOA) with the Municipal Mayor of Morong, Honorable Armando D.G. San Juan, for the granting of additional financial assistance fund to the Municipal Government of Morong, in the amount of Seven Million Pesos (Php7,000,000.00), earmarked to cover the expenses for the education related requirements of the ISFs-Relocatees from Quezon City resettled to National Housing Authority (NHA) Resettlement Site in the Municipality of Morong, Province of Rizal.
