A RESOLUTION REQUESTING THE QUEZON CITY HOUSING, COMMUNITY DEVELOPMENT AND RESETTLEMENT DEPARTMENT (HCDRD) TO CONDUCT A CENSUS OF INFORMAL SETTLERS RESIDING IN HILLTOP NOVALICHES SUBDIVISION'S OPEN SPACES AND ROAD LOT 1, BARANGAY GREATER LAGRO, QUEZON CITY.

WHEREAS, these properties are now being occupied by the early occupants, buyers of rights, professional squatters, tenants, etc.;


WHEREAS, to maintain peace and order in Hilltop Subdivision, a census of the occupants in these areas is in order;
