RESOLUTION NO. SP- **7461**, S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND IMMEDIATE FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT TO THE PROVINCE OF ALBAY WHICH WAS AFFECTED BY THE ERUPTION OF MAYON VOLCANO IN THE AMOUNT OF TEN MILLION PESOS, (P10,000,000.00) THE SAID AMOUNT SHALL BE TAKEN FROM THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND.

WHEREAS, the recent and continuing eruption of Mayon Volcano has displaced thousands of residents and caused the reduction or stoppage of basic services in the Local Government Units of Tabaco, Ligao, Guinobatan, Camalig, Daraga, Legazpi, Sto. Domingo, Malilipot, and Bacacay in the Province of Albay;

WHEREAS, MMDA Resolution No. 18-02, Series of 2018, enjoins the MM LGUs to join and support the "Mayon Caravan" and shall provide to the Albay LGU's much needed relief goods, medical assistance, and disaster response teams;

WHEREAS, Mayon Volcano in the Albay Province, one of the most known active volcanoes in the Philippines, spewed ashes last January 15, 2018 and was closely monitored by the Philippine Institute of Volcanology and Seismology;

WHEREAS, foods and medical supplies are the growing concerns of all the sixty-nine (69) temporary shelters away from the danger zone;

WHEREAS, Ms. Romina Marasigan, spokesperson of NDRRMC when interviewed said that more than 3,000 families or close to 12,000 individuals flee from the Mayon Volcano's restlessness the figure mentioned exclude families that are forced to evacuate;

WHEREAS, due to the continues activity of Mayon Volcano, the six-kilometer danger zone around it was extended to 8-kilometers, after proper authorities reported that the volcano's crater was glowed, an indication of upcoming lava flow;

WHEREAS, according to Philvocs, a total of thirteen (13) tremor events, six (6) of which corresponds to the lava fountaining events, two (2) episodes of pyroclastic density current or PDC generation from lava collapse, and numerous rock fall events were recorded by Mayon seismic monitoring network thus alert level 4 remains in effect over Mayon Volcano;


WHEREAS, Mayon Volcano's eruption also destroys P160 million worth of Agricultural Products;

WHEREAS, Rule 18, Section 1 of the Implementing Rules and Regulations of Republic Act No. 10121 (The Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the LDPPMC and approval of the Sangunian concerned, the LDRRMCs may transfer the said fund to support the disaster risk reduction of other LDRRMCs which are declared under state of calamity.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend immediate financial assistance in behalf of the Quezon City Government in the amount of Ten Million Pesos (P10,000,000.00) to the province of Albay which was affected by the eruption of Mayon Volcano, the said financial assistance shall be taken from the Quezon City Disaster Risk Reduction and Management Fund.

RESOLVED, FURTHER, that the Municipalities of Guinobatan, Camalig, Daraga, Sto. Domingo, Malilipot, Bacacay, as well as the cities of Ligao, Legazpi and Tabaco shall receive One Million Pesos (P1,000,000.00) each and another One Million Pesos (P1,000,000.00) for "Mayon Caravan" that shall be taken from the said allocation.






