BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate One (1) unit of Motor Vehicle Ambulance to Barangay Holy Spirit, Quezon City.

RESOLVED, FURTHER, that the ownership of the same be transferred to the recipient, through a Deed of Donation, to be signed by the City Mayor, Honorable Herbert M. Bautista and Honorable Estrella C. Valmocina as Donor, Punong Barangay Felicito A. Valmocina of Barangay Holy Spirit as Donee, with the City Department Head III, City General Services Department (CGSD) and the Barangay Operations Center as Witnesses.
