*WHEREAS, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates each local government unit to prepare a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian;*

*WHEREAS, the City Development Council (CDC), pursuant to the Local Government Code of 1991, is mandated to formulate long term, medium term and annual socio-economic development plans and policies;*

*WHEREAS, the five (5) development sectors represented by the CDC committee representatives and concerned executive offices/departments have undergone series of meetings, trainings and consultations for the preparation of the City's Comprehensive Development Plan (CDP);*

WHEREAS, the CDP is the plan wherein the LGU promotes the general welfare of its inhabitants. It consolidates the programs and projects necessary to carry out the objectives of the different development sectors;


WHEREAS, the CDP, prepared by the core technical working group, was presented to the concerned sectoral committee which gave their approval and recommended to be endorsed for CDC's adoption;

WHEREAS, the Sangguniang Panlungsod, as the legislative body of the local government unit, must adopt and approve the Comprehensive Development Plan (CDP) of Quezon City.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to adopt, as it does hereby adopt the Comprehensive Development Plan of the Quezon City Government for the Period 2017-2020.
