RESOLUTION NO. SP. 7497 , S-2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED TO BE USED BY THE CENSUS TEAM OF THE CENSUS SURVEY SECTION OF HOUSING, COMMUNITY DEVELOPMENT AND RESETTLEMENT DEPARTMENT (HCDRD), IN THE PERFORMANCE OF ITS OFFICIAL FUNCTION SPECIFICALLY CENSUS SURVEY OF INFORMAL SETTLER FAMILIES (ISFs) WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY.

WHEREAS, the Census Survey Section of the Housing, Community Development and Resettlement Department (HCDRD), with its regular function of conducting census survey of informal settler families (ISFs) in Quezon City, has twelve (12) personnel who regularly perform field works as a Census Team comprising of tagger, mapper and census interviewers;

WHEREAS, the HCDRD Census Team has been assigned a unit of Avanza as their means of transportation to and from their place of work or area to be surveyed, which assigned vehicle can only accommodate 5-6 persons per trip;

WHEREAS, oftentimes, the Census Team is being transported to and from the area to be surveyed using two (2) trips or by an additional vehicle assigned to other unit of HCDRD, thereby delaying or even conflicting with schedule of said unit of the Department;

WHEREAS, considering the situation, HCDRD realized that the motor vehicle to be procured would be practical and enough to accommodate and transport all members of its Census Team using one trip;

WHEREAS, there is a need for the Quezon City Council to allow and approve the purchase of said vehicle through a Council Resolution;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of Motor Vehicle intended to be used by the Census Team of the Census Survey Section of Housing, Community Development and Resettlement Department (HCDRD), in the performance of its official function specifically census survey of informal settler families (ISFs) within the territorial jurisdiction of Quezon City.
