WHEREAS, the Quezon City Government is the owner of parcels of land consisting of twenty (20) road lots, five (5) alleys and three (3) open spaces located at Northwind Subdivision, Barangay Nagkaisang Nayon, Quezon City;

WHEREAS, the said road lots and open space was donated to the Quezon City Government by Sta. Lucia Realty and Development, Inc., the developer of Northwind Subdivision;

WHEREAS, Northwind Subdivision Homeowners Association, Inc. made representation with the Quezon City Government to grant the association the right to use, supervise, upkcep and secure all road lots, alleys and open space donated to the city located at Northwind Subdivision, Barangay Naykaisang Nayon, Quezon City.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista. Quezon City, to sign the Memorandum of Agreement with Northwind Subdivision Homeowners Association, Inc., represented by its President, Ms. Aida S. Kapawan, granting the association the use, supervision, upkeep and security of road lots and open space donated to the city by Sta., Lucia Realty and Development, Inc. located at Northwind Subdivision, Barangay Nagkaisang Nayon, Quezon City.
