A RESOLUTION GRANTING A SPECIAL PERMIT TO TOP WIN LUCKY GAMING CORPORATION, FOR THE OPERATION OF A PAGCORLICENSED E-BINGO BOUTIQUE LOCATED AT ISETANN SUPERMARKET, NO. 295 P. TUAZON STREET, CUBAO, QUEZON CITY, FOR PURPOSES OF HOLDING ELECTRONIC BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Top Win Lucky Gaming Corporation, a duly registered entity under and by virtue of the laws of the Republic of the Philippines with principal office at No. 187 EMGP Building, España Blvd. Barangay 503 Zone 50 Sampaloc, Manila, through its representative, Ma. Narissa M. Moral, is applying for a special permit to operate an Electronic Bingo Games in Quezon City;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Top Win Lucky Gaming Corporation the authority to operate an Electronic Bingo Boutique where said games may be played;

WHEREAS, under the provisions of Republic Act. No. 7160. otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or licenses.

## NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Top Win Lucky Gaming Corporation, to operate an Electronic Bingo Boutique located at Isetann Supermarket. No. 295 P. Tuazon Street, Cubao, Quezon City, for purposes of holding an Electronic Bingo Games, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the outhority to operate an Electronic Bingo Games granted herein shall be subject to the following limitations:

- a. The holding of Electronic Bingo Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic Bingo Games shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentioned games.

RESOLVED, FURTHERMORE, that Top Win Lucky Gaming Corporation shall remit to the City Treasurer's Office a Franchise Fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.
