RESOLUTION NO. SP- **7572**, S-2018

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, WITH ABS-CBN LINGKOD KAPAMILYA FOUNDATION, INC. (ALKFI), FOR THE ACCOMMODATION OF CHILDREN WHO HAVE BEEN ABUSED, ABANDONED, NEGLECTED OR EXPLOITED FROM QUEZON CITY OR HAD BEEN REPEATEDLY FOUND IN AND/OR RESCUED FROM THE STREETS OF QUEZON CITY AT THE BANTAY BATA 163 CHILDREN'S VILLAGE, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Local Government of Quezon City (LGU-QC) is committed to its objective of delivering to its constituents all the necessary assistance that it can provide;

WHEREAS, the LGU-QC, pursuant to its mandate, provides protection and welfare services to abused, neglected, abandoned and exploited children and their families through its various social welfare programs and services;

WHEREAS, the ABS-CBN Lingkod Kapamilya Foundation, Inc., (ALKFI), a non-stock, non-profit socio-civic corporation organized and existing under Philippine Laws, through its Bantay Bata 163 Program, recognizes and promotes the welfare of abused, neglected, abandoned and exploited children, and actively seeks out partners and donations and sponsors and donors to ensure sustainable operations in pursuit of its advocacy and service delivery;

WHEREAS, ALKFI owns the property located in Norzagaray, Bulacan, with an area of some 2.5 hectares, covered by Transfer Certificate of Title No. T-42392 P(M) as issued by the Registry of Deeds of Bulacan, Meycauayan Branch, including several permanent structures and improvements therein currently known as the "Bantay Bata 163 Children's Village";

WHEREAS, under the Memorandum of Agreement, the Parties intend and commit to join, pool resources and establish a partnership to provide comprehensive child care and protection services to children below 18 years old who are neglected, abandoned, abused and/or exploited and/or those at risk by ensuring that residential care services are made available at the Children's Village;

WHEREAS, there is a need to ratify the Memorandum of Agreement signed by the parties and the duly signed Memorandum of Agreement shall form an integral part of this Resolution;

WHEREAS, the City Council hereby authorized the City Mayor, Honorable Herbert M. Bautista, for and in behalf of the Local Government of Quezon City, to enter and sign a Memorandum of Agreement with ABS-CBN Lingkod Kapamilya Foundation, Inc.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by the Quezon City Government, represented by the City Mayor, Honorable Herbert M. Bautista, with ABS-CBN Lingkod Kapamilya Foundation, Inc., for the accommodation of children who have been abused, abandoned, neglected or exploited from Quezon City or had been repeatedly found in and/or rescued from the streets of Quezon City at the Bantay Bata 163 Children's Village, subject to existing laws, rules and regulations.


