**A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT SIGNED BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, ON BEHALF OF THE QUEZON CITY GOVERNMENT WITH THE EMBASSY OF ISRAEL IN MANILA FOR THE CONSTRUCTION OF A "FRIENDSHIP PARK" AT THE QUEZON CITY MEMORIAL CIRCLE.**

*WHEREAS, as part of the "Thank You Philippines Campaign" of the Israeli Government and to mark Six Decades of diplomatic relations and mutual alliance between the Philippines and Israel, a "Friendship Park" is proposed to be constructed at the Quezon Memorial Circle;*

*WHEREAS, the proposed "Friendship Park" shall epitomize the continuing friendship between the two countries;*




