RESOLUTION NO. SP- 7585, S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DOUBLE "M" CONSTRUCTION AND DEVELOPMENT CORPORATION FOR THE CONSTRUCTION/RENOVATION OF A FOUR (4)-STOREY COMMERCIAL SPACE (AS BUILT) LOCATED AT ANONAS EXTENSION CORNER MATIPID STREET, SIKATUNA VILLAGE, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502 S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Double "M" Construction and Development Corporation, represented by Mary Jane M. Regala, is applying for a Certificate of Exception for the construction/renovation of a Four (4)-Storey Commercial Space (As Built) located at Anonas Extension corner Matipid Streets, Sikatuna Village, Quezon City;

WHEREAS, pursuant to Section 55, Article VIII, in relation to Section 73, Article IX of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an Exception is required for the aforesaid project only upon authorization from the City Council;

WHEREAS, the applicant is required to allot in their proposed project five (5) percent of the total parking lot/space exclusively for the use of visitors, clients or customers as mandated by Ordinance No. SP-2582, S-2017;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has complied with the necessary requirements prescribed by law, ordinance or administrative issuances.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Double "M" Construction and Development Corporation for the construction/renovation of a Four (4)-Storey Commercial Space (As Built) located at Anonas Extension corner Matipid Street, Sikatuna Village, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
