A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TRIPLEF54 STAR CORPORATION, FOR THE CONSTRUCTION AND OPERATION OF A CALTEX GASOLINE STATION LOCATED AT EDSA CORNER SCOUT BORROMEO STREET, BARANGAY SOUTH TRIANGLE, QUEZON CITY.

WHEREAS, petitioner TRIPLEF54 Star Corporation, a business entity duly registered under Philippine Laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Caltex Gasoline Station located at EDSA corner Scout Borromeo Barangay South Triangle, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit only upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance;
