*WHEREAS, Ms. Cabel graduated with a Bachelor's Degree in Veterinary Medicine. She obtained her license for passing the Veterinary Board Exam in 1985. Ms. Cabel also holds a Master's Degree in Public Administration and Good Governance;*

WHEREAS, the Quezon City Council believes in her capacity and commends her persistence and continuing improvement of oneself to better serve our citizens.


NOW, THEREFORE,
