WHEREAS, the Iglesia Ni Cristo (INC) has extended help by conducting relief distribution in Iligan and Balo-i in Lanao del Norte to the Marawi evacuees affected by the ongoing Marawi siege;

WHEREAS, during the relief distribution the Iglesia Ni Cristo have sent relied goods and mobilized 1,000 members for operations in several evacuation centers that with approximately 95,000 evacuees more or less;

WHEREAS, for the last several years the Iglesia Ni Cristo's Lingap sa Mamamayan has been extended not only from relief distribution but also from livelihood and assistance programs for church members and non-members alike;
