RESOLVED, FURTHER, that the ownership of the said vehicle be transferred to the recipient through a Deed of Donation, to be signed by the Honorable City Mayor Herbert M. Bautista as the representative of Quezon City, the Punong Barangay as the representative of the concerned barangay, and Head of the City General Services Department (CGSD).
