A RESOLUTION CONGRATULATING KA EDUARDO V. MANALO, EXECUTIVE MINISTER OF IGLESIA NI CRISTO, FOR BEING APPOINTED AS SPECIAL ENVOY FOR OVERSEAS FILIPINO WORKER (OFW).

WHEREAS, the Iglesia Ni Cristo (Church of Christ) is a Christian religious sect whose membership comprises of at least 110 nationalities and maintains more than 100 ecclesiastical districts in the Philippines, more than 5,000 local congregations, and more than 1,000 congregations found in more than 100 countries and territories;

WHEREAS, Brother Eduardo V. Manalo became the 3rd Executive Minister of the Iglesia Ni Cristo on September 7, 2017;

WHEREAS, Brother Eduardo V. Manalo has charismatically and dedicatedly led the 21st Century Iglesia Ni Cristo by personally tending to the flock in all parts of the world to nurture their spiritual well-being;

WHEREAS, Brother Eduardo has steadily steered the Church towards the march of triumphs here and abroad and led it into being a church for the masses, propagating the Christian doctrine to love and care for one's neighbor accounting for the Church's sincere efforts to reach out to those in need;

WHEREAS, Brother Eduardo Manalo's leadership of the INC saw ecclesiastical districts established outside of the Philippines such as in the United Kingdom, Canada, Middle East, United Arab Emirates, China, Australia, and Southeast Asia among others;

WHEREAS, Brother Eduardo serves as an inspiration not only to the members of the Iglesia Ni Cristo, but the entire nation that is at the receiving end of the charitable and spiritual support of the Church, particularly its Lingap sa Mamamayan (Aid for Humanity), a keen humanitarian sense of being there for all those who have fallen into distress either on account of natural calamities of man-made strife by responding to their cries and coming to their aid;

WHEREAS, on February 14, 2018, President Rodrigo R. Duterte, appointed Mr. Eduardo V. Manalo as Special Envoy for Overseas Filipino Workers from January 30, 2018 to January 29, 2019.
