RESOLUTION NO. SP- **7663**, S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TRIPLE MCC FUEL TRADING (PTT GASOLINE STATION), FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION TO BE LOCATED AT LOT 9 BLOCK 167 COMMONWEALTH AVENUE, BARANGAY NORTH FAIRVIEW, QUEZON CITY.

Introduced by Councilor **MARVIN C. RILLO**.

WHEREAS, Triple MCC Fuel Trading, owned by PTT Gasoline Station, represented by Mr. Crestine C. Cheng, with office address at Lot 9 Block 167 Commonwealth Avenue, Quezon City, is applying for a Special Use Permit for the construction and operation of a Gasoline Refilling Station to be located at Lot 9 Block 167 Commonwealth Avenue, Barangay North Fairview, Quezon City;

WHEREAS, pursuant to the provisions of the existing Quezon City Zoning Ordinance, Gasoline Refilling Station is among the uses which require the issuance of a Special Use Permit only upon authorization from the Quezon City Council;

WHEREAS, the Sangguniang Barangay of Barangay North Fairview and the neighborhood concerned had interposed no objection to the proposed project;

WHEREAS, the proposed project will provide employment to the barangay residents and will help boost the economic condition of the city;

WHEREAS, the applicant will comply with the necessary requirements as mandated by the said Zoning Ordinance and pertinent rules and regulations. ✓
