RESOLUTION NO. SP- 7678, S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MR. WARREN S. SO, FOR THE CONSTRUCTION OF TEN (10) UNITS/THREE (3)-STOREY SINGLE DETACHED RESIDENCES TO BE LOCATED AT LOTS 3-B AND 4/BLOCK 3 BROADWAY AVENUE CORNER 7th STREET, BARANGAY MARIANA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Mr. Warren S. So is applying for a Certificate of Exception for the construction of ten (10) units/three (3)-storey single detached residences to be located at Lots 3-B and 4/Block 3 Broadway Avenue Corner 7th Street, Barangay Mariana, Quezon City;

WHEREAS, in accordance with the provisions of Article V Section 13, Article VI Section 32 and 33, Section 40 item (1-3), Article VIII Section 55(2) and Article IX, Section 73 of the Quezon City Zoning Ordinance No. SP-2502, S-2016, an Exception is required for project to which the proposed undertaking falls under.

WHEREAS, the applicant is required to allot in their proposed project five percent (5%) of the total parking lot/space exclusively for the use of visitors, client or customers as mandated by Ordinance No. SP-2582, S-2017; y

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize as it does hereby authorize the issuance of a Certificate of Exception to Mr. Warren S. So, for the construction of ten (10) units/three (3)-storey single detached residences to be located at Lots 3-B and 4/Block 3 Broadway Avenue corner 7th Street, Barangay Mariana, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
