WHEREAS, Princess Home Realty and Developers, Inc. is the registered owner of the parcels of land located inside the subdivision known as Goldkey Classicville located at Barangay Bagbag, Quezon City;

WHEREAS, the Housing and Land Use Regulatory Board (HLURB) has issued a Certificate of Completion that Princess Home Realty and Developers, Inc. has completely subdivided and developed the above-mentioned subdivision;
