WHEREAS, the Novaliches District Hospital (NDH), a local government hospital duly created under Ordinance No. SP-997, S-2001, is one of the chosen hospital institutions by the Office of the President, where a One-Stop Shop will be established for the implementation of the "Malasakit Center", a project intended to provide financial assistance to indigent clients served through in-patient admissions and out-patient consultations of the hospital;

WHEREAS, to hasten the delivery of medical services to the underprivileged, it is necessary to formulate a mechanism that would provide easy access to financial assistance funds to defray the expenses for medication and hospitalization;

WHEREAS, the "Malasakit Center" is formed to streamline the access for financial assistance for the poor to avail of the funds being extended by partner government institutions/agencies, Department of Social Welfare and Development (DSWD), Philippine Health Insurance Corporation (PhilHealth), Philippine Amusement and Gaming Corporation (PAGCOR), and Philippine Charity Sweepstakes Office (PCSO);

WHEREAS, there is a need to open a separate bank account to be utilized for the "Malasakit Center" where the funds therefor will be saved and dedicated for the purpose as its depository bank.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Novaliches District Hospital, located at Quirino Highway, Barangay San Bartolome, District 5, Quezon City, to open a separate bank account for the utilization of "Malasakit Center".
