A RESOLUTION AMENDING RESOLUTION NO. SP-7510, S-2018, ENTITLED "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE UTILIZED BY THE QUEZON CITY HEALTH DEPARTMENT (QCHD)-QUEZON CITY GOVERNMENT (QCG), FOR THE EFFECTIVE IMPLEMENTATION, OPERATION AND MONITORING OF PROGRAMS AND PROJECTS OF THE CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS", CHANGING THE AMOUNT FROM ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PHP1,250,000.00) TO ONE MILLION SEVEN HUNDRED TWENTY-FIVE THOUSAND PESOS (PHP1,725,000.00).
