WHEREAS, Malasakit Center is an initiative of the Office of the President (OP) in cooperation with the Department of Health (DOH), DOH-retained hospitals in Quezon City, Philippine Health Insurance Corporation (PHIC) or PhilHealth, Philippine Charity Sweepstakes Office (PCSO), Department of Social Welfare and Development (DSWD) and proposed Non-Government Organizations – Federacion International De Abogadas (FIDA), Women's Health Care (WHC), Pinoy Plus, etc.; †

WHEREAS, the Center aims to assist the government in the efficient delivery of government services to the public;

WHEREAS, it shall serve as one-stop service center instituted for the purpose of expediting the processes in availing financial assistance for healthcare services;

WHEREAS, the Center pursuant to the provisions of the 1987 Constitution on Health which expressly provides that "...There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children...";

WHEREAS, the Center is also in response to the earnest desire of His Excellency, President Rodrigo Roa Duterte, to help the poor who are in need of medical assistance;

WHEREAS, the OP shall be responsible for the funding while Novaliches District Hospital shall provide space and necessary personnel for the operation of the said Center;

WHEREAS, the Malasakit Center will allow patients to avail of government services under one roof to make it more convenient, especially the indigent and marginalized, to get medical assistance from the government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance. ✕



NOW, THEREFORE,




