A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNO FUEL, INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION LOCATED AT LOT 2, BLOCK K-63, KAMIAS ROAD, BARANGAY WEST KAMIAS, DISTRICT 3, QUEZON CITY.

WHEREAS, Uno Fuel, Incorporated, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located at Lot 2, Block K-63, Kamias Road, Barangay West Kamias, District 3, Quezon City;

WHEREAS, the Sangguniang Barangay of West Kamias and the residents therein interposes no objection to the proposed construction because of the benefits and development that would be realized out of the said project and a public consultation with neighboring residents was properly conducted;

WHEREAS, the construction and operation of a gas station will provide local employment within the vicinity and promote economic development in the barangay as well as the City;


WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit is required for this project;

WHEREAS, the proposed gasoline station has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance.

NOW, THEREFORE,


