WHEREAS, Unioil Petroleum Philippines, Incorporated a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline refilling station to be located at Lots 6-C and 6-D Mindanao Avenue, Barangay Talipapa, Quezon City;
