A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG), THROUGH CITY MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE FOR FISCAL YEAR 2019 TO THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT-NATIONAL CAPITAL REGION (DILG-NCR), IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), SUBJECT TO THE EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government (QCG), through the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance for Fiscal Year 2019 to the Department of the Interior and Local Government-National Capital Region (DILG-NCR), in the amount of Ten Million Pesos (Php10,000,000.00), subject to the existing accounting and auditing laws, rules and regulations.


