A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT LOTS 7 AND 8, BLOCK 1, ZABARTE ROAD, BARANGAY KALIGAYAHAN, QUEZON CITY, IN ACCORDANCE WITH THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016.


