WHEREAS, Republic Act No. 10661 declares November of every year as National Children's Month in commemoration of the adoption of the Convention on the Rights of the Child by the United Nations General Assembly on November 20, 1989;

WHEREAS, to celebrate the National Children's Month, this resolution enjoins all barangays in Quezon City to conduct an Annual Barangay General Assembly of Children, herein referred as the General Assembly, in their jurisdiction;

WHEREAS, the General Assembly is recommended to include, among others, a State of the Children's Report in the Barangay to be delivered by the Punong Barangay, and a consultation with children on the formulation and evaluation of the implementation of the Barangay Development Plan for Children;


WHEREAS, the conduct of the General Assembly would enhance the coordination of barangays with the children in their community and would likewise serve as a venue for the participation of children.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge all barangays in Quezon City to conduct an Annual Barangay General Assembly of Children during the Children's Month in November.

RESOLVED, FURTHER, that a copy of this Resolution be furnished to all barangays in Quezon City.


