A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT FOR AND IN BEHALF OF THE QUEZON CITY GOVERNMENT THE DONATION OF ONE (1) UNIT OF AMBULANCE VEHICLE MADE BY THE OFFICE OF THE HONORABLE CONGRESSMAN ALFRED D. VARGAS III OF DISTRICT 5, QUEZON CITY, THROUGH THE DEPARTMENT OF HEALTH (DOH) FOR THE SOLE USE OF NOVALICHES DISTRICT HOSPITAL (NDH) LOCATED AT QUIRINO HIGHWAY, BARANGAY SAN BARTOLOME, DISTRICT 5, QUEZON CITY.

WHEREAS, at present, the increasing number of patients being accommodated and served by the Novaliches District Hospital makes it imperative to improve its health services, most particularly the transport capability of the hospital that would further achieve its mandate;



Vargas III of District 5, Quezon City, through the Department of Health (DOH) for the sole use of Novaliches District Hospital (NDH) located at Quirino Highway, Barangay San Bartolome, District 5, Quezon City.
