WHEREAS, the *Liga ng mga Barangay-District V*, Quezon City has been established and sanctioned by the Quezon City Government to be involved in the formation and implementation of the Quezon City's plans, programs, projects and activities under its partnership program;

WHEREAS, the *Liga ng mga Barangay-District V*, Quezon City is requesting for a financial assistance amounting to One Million Pesos (Php1,000,000.00) to help defray the expenses of their programs and projects, particularly in the conduct of team-building and seminars for the formulation of Executive Policies that will help ensure the effective implementation of city development policies;

WHEREAS, pursuant to Section 36 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", expressly provides:

Section 36. Assistance to People's and Non-Governmental Organizations. – A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, to grant financial assistance in the amount of One Million Pesos (Php1,000,000.00) to the Liga ng mga Barangay-District V, Quezon City, subject to existing laws, rules and regulations.
