RESOLUTION NO. SP- 7861, S-2019

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO ANDOK'S LITSON CORPORATION FOR THE CONSTRUCTION OF A TWO (2)-STOREY WAREHOUSE FOR COLD STORAGE AND COMMISSARY BUILDING (AS BUILT), LOCATED AT NO. 26 BULACAN STREET, BARANGAY BUNGAD, WEST AVENUE, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Andok's Litson Corporation is a corporation duly organized and existing under and by virtue of Philippine laws, with principal business address at No. 24 Bulacan Street, Barangay Bungad, Quezon City;

WHEREAS, Ms. Ruth R. Gaspar, Administrative Manager and representative of Andok's Litson Corporation, is applying for a Certificate of Exception for the use of the parcel of land under TCT No. N201109 for the construction of a Two (2)-storey warehouse for cold storage and commissary building (as built) located at No. 26 Bulacan Street, Barangay Bungad, West Avenue, Quezon City. The said location is classified under Major Commercial Zone (C-2) as provided in the Quezon City Zoning Ordinance of 2016;

WHEREAS, based on the submitted plan, the project does not comply with the parking requirements;


WHEREAS, the existing project of Andok's Litson Corporation will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, in accordance with the provisions of Article IX, Section 73 of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an Exception is required for projects to which the proposed undertaking falls under.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Andok's Litson Corporation for the construction of a Two (2)-Storey warehouse for cold storage and commissary building (as built), located at No. 26 Bulacan Street, Barangay Bungad, West Avenue, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502 S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.


