RESOLUTION NO. SP- **8435**, S-2020

A RESOLUTION GRANTING THE SPECIAL PERMIT TO ANYTIME GAMING EXPERIENCE, INC. TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT LOCATED AT 2/F COMMONWEALTH MARKET, BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

*WHEREAS, Anytime Gaming Experience, Inc. is a domestic business entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines located at 2/F Commonwealth Market, Barangay Commonwealth, District II, Quezon City;*

*WHEREAS, the said entity is applying for a Special Permit with the Quezon City Council for the operation of E-Games;*

*WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Anytime Gaming Experience, Inc. an authority to operate an electronic gaming establishment where said games may be played;*

WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or Licenses;

WHEREAS, the Sangguniang Barangay of Commonwealth issued a Resolution interposing no objection to the application to operate an electronic gaming business at 2/F Commonwealth Market, Barangay Commonwealth, District II, Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the Special Permit to Anytime Gaming Experience, Inc. to operate an electronic games (e-games) establishment located at 2/F Commonwealth Market, Barangay Commonwealth, District II, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate E-Games and E-Bingo granted herein shall be subject to the following limitations:

- a. The holding of E-Games/Bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of E-Games/Bingo shall not include playing of games not related to those sanctioned by PAGCOR;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.

RESOLVED FURTHERMORE, that Anytime Gaming Experience, Inc. shall remit to the City Treasurer's Office a Franchise fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.




