RESOLUTION NO. SP- 8925, S-2022

A RESOLUTION RENEWING THE SPECIAL PERMIT OF B-7 AMUSEMENTS TO OPERATE ELECTRONIC CORPORATION BINGO (E-BINGO) AND **ELECTRONIC GAMES** (E-GAMES) AT2/F**BERKELEY** SQUARE, COMMONWEALTH AVENUE, **BARANGAY** *MATANDANG* BALARA, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, B-7 Amusements Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at 2/F Berkeley Square, Commonwealth Avenue, Barangay Matandang Balara, District III, Quezon City;

WHEREAS, B-7 Amusements Corporation is primarily engaged in the business of Electronic Bingo (E-Bingo) and Electronic Games (E-Games);

WHEREAS, to enable the applicant to operate Electronic Bingo (E-Bingo) and Electronic Games (E-Games) in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, B-7 Amusements Corporation is requesting the City Council to renew the Special Permit granted to operate Electronic Bingo (E-Bingo) and Electronic Games (E-Games).
