RESOLUTION NO. SP. 8927, S-2022

A RESOLUTION RENEWING THE SPECIAL PERMIT OF BINGO PALACE CORPORATION TO OPERATE TRADITIONAL BINGO AND ELECTRONIC BINGO (E-BINGO) AT PUREGOLD-NOVALICHES, NO. 1018 BARANGAY STA. MONICA, QUIRINO HIGHWAY, NOVALICHES, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Bingo Palace Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at Puregold-Novaliches, No. 1018 Barangay Sta. Monica, Quirino Highway, Novaliches, Quezon City;

WHEREAS, Bingo Palace Corporation is primarily engaged in the business of Traditional Bingo and Electronic Bingo (E-Bingo);

WHEREAS, to enable the applicant to operate Traditional Bingo and Electronic Bingo (E-Bingo) in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Bingo Palace Corporation is requesting the City Council to renew the Special Permit granted for the operation of Traditional Bingo and Electronic Bingo (E-Bingo).

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Bingo Palace Corporation to operate Traditional Bingo and Electronic Bingo (E-Bingo) at Puregold-Novaliches, No. 1018 Barangay Sta. Monica, Quirino Highway, Novaliches, Quezon City, subject to the rules and regulations promulgated by Philippine Amusement and Gaming Corporation (PAGCOR).
