A RESOLUTION RENEWING THE SPECIAL PERMIT OF BINGO PARADISE INC. TO OPERATE ELECTRONIC BINGO (E-BINGO), TRADITIONAL BINGO AND ELECTRONIC GAMES (E-GAMES) AT 2/F METROLANE COMPLEX, P. TUAZON STREET CORNER 20<sup>TH</sup> AVENUE, PROJECT 4, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Bingo Paradise Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at 2/F Metrolane Complex, P. Tuazon Street corner 20<sup>th</sup> Avenue, Project 4, Quezon City;

WHEREAS, Bingo Paradise Inc. is primarily engaged in the business of Electronic Bingo (E-Bingo), Traditional Bingo and Electronic Games (E-Games);

WHEREAS, to enable the applicant to operate Electronic Bingo (E-Bingo), Traditional Bingo and Electronic Games (E-Games) in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Bingo Paradise Inc. is requesting the City Council to renew the Special Permit granted for the operation of Electronic Bingo (E-Bingo), Traditional Bingo and Electronic Bingo (E-Bingo).
