A RESOLUTION LAUDING THE ANTI-CRIME AND TERRORISM COMMUNITY INVOLVEMENT AND SUPPORT (ACT-CIS) PARTY LIST FOR SECURING THE TOP SPOT IN THE PARTY-LIST RACE DURING THE MAY 2022 ELECTIONS.

WHEREAS, the Anti-Crime and Terrorism Community Involvement and Support (ACT-CIS) Party List is a political organization which has party-list representation in the House of Representatives of the Philippines;

WHEREAS, in May 2022 National Elections, ACT-CIS secured the top spot in the party-list race, with a whooping 2,111,091 votes, gaining three seats at the House of Representatives;

WHEREAS, ACT-CIS also garnered the most number of votes in the party-list race with 2,651,987 votes in the 2019 National Elections;

WHEREAS, ACT-CIS has been the leading advocate in the fight for equal protection and standardize remuneration for media workers;

WHEREAS, ACT-CIS authored the “Media Workers Welfare Act” which endeavored to achieve the following objectives: to ensure that media workers shall be provided with comprehensive benefits packaged at par with the current benefits enjoyed by those in the labor force both in government and the private sector; to motivate and encourage media workers to perform their duties as truthful and responsible informers of the people; and to ensure the creation of a safe, protected, and an atmosphere conducive to a productive, free, and fruitful media work;

WHEREAS, ACT-CIS, during the height of the COVID-19 pandemic, extended support to the Quezon City government in accelerating the latter’s vaccination and inoculation efforts. Mayor Joy Belmonte and ACT-CIS’ previous chairperson, Erwin Tulfo, signed a memorandum of agreement which provided for the designation of ACT-CIS’ doctors (10) and nurses (16) to Quezon City vaccination hubs and inoculation sites;

WHEREAS, ACT-CIS has institutionalized programs that provide aid to those who need medical assistance by providing financial aid, check-ups, medicines and dialysis procedures;

WHEREAS, ACT-CIS, known for its slogan “Kakampi ng mga Inaapi”, has been a strong advocate for the oppressed and the abused;

WHEREAS, ACT-CIS, whose nominees are Representatives Edvic Yap, Jocelyn Tulfo and Jeffrey Soriano, aims to introduce innovations and reforms to fulfill the justice aspirations of the Filipino people by enacting more laws that will aid vulnerable persons against abuse from both private and government malefactors.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to laud, as it does hereby laud, the Anti-Crime and Terrorism Community Involvement and Support (ACT-CIS) Party List for securing the top spot in the party-list race during the May 2022 Elections.
