RESOLUTION NO. SP- 9080, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH - METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD), REPRESENTED BY DIRECTOR IV, GLORIA J. BALBOA, M.D., FOR THE ACCEPTANCE OF THE CASH GRANT IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP150,000.00) IN RECOGNITION OF THE QUEZON CITY'S EXEMPLARY PERFORMANCE IN ITS NATIONAL HUMAN IMMUNODEFICIENCY VIRUS (HIV), ACQUIRED IMMUNODEFICIENCY SYNDROME (AIDS) AND SEXUALLY TRANSMITTED INFECTION (STI) PREVENTION AND CONTROL PROGRAM IMPLEMENTATION.

WHEREAS, the DOH remains steadfast in recognizing men and women who selflessly and unconditionally dedicated their time and effort to move the country closer to the attainment of the Universal Health Care (UHC);

WHEREAS, distinguished individuals and organizations with an exemplary implementation of the various health programs and/or projects that made an impact in improving the health status of their respective communities deserve to be emulated and recognized;

WHEREAS, the Department of Health allotted One Hundred Fifty Thousand Pesos (Php150,000.00) cash grant as specified in its approved 2022 Work and Financial Plan for Quezon City Government which delivered the best health practices in its National Human Immunodeficiency Virus (HIV), Acquired Immunodeficiency Syndrome (AIDS) and Sexually Transmitted Infection (STI) Prevention and Control Program Implementation;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Department of Health - Metro Manila Center for Health Development (DOH-MMCHD), represented by Director IV, Gloria J. Balboa, M.D., for the acceptance of the cash grant in the amount of One Hundred Fifty Thousand Pesos (Php150,000.00) in recognition of the Quezon City's exemplary performance in its National Human Immunodeficiency Virus (HIV), Acquired Immunodeficiency Syndrome (AIDS) and Sexually Transmitted Infection (STI) Prevention and Control Program Implementation.
