A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE OF MOTORCYCLE UNITS FROM GUANZON MERCHANDISING CORPORATION, MINERVA TRADING HOUSE OF MOTORCYCLES, INC. AND EASTWORLD MOTOR INDUSTRIES CORPORATION FOR THE USE OF THE CITY'S INTENSIFIED TAX COLLECTION EFFORTS.

WHEREAS, the Local Chief Executive may, upon authority of the Sangguniang Panlungsod, negotiate and secure financial grants or donation in kind in support of basic services or facilities enumerated in Section 17 of Republic Act No. 7160;

WHEREAS, the Honorable City Mayor is authorized to enter into contracts pursuant to Section 51(b) of the Administrative Code of 1987;

WHEREAS, under Section 17 of Republic Act No. 7160, the Local Government may exercise such powers and discharge such functions as may be necessary, appropriate or incidental to the delivery of basic services and facilities including tax information systems;

WHEREAS, to intensify its tax collection efforts which will lead to the increase of locally sourced revenues, there is a need to improve the transportation services of the City Treasurer's Office, through the use of fuel efficient motorized vehicles;

WHEREAS, in its desire to assist the Quezon City LGU to improve its tax collection, Guanzon Merchandising Corporation, Minerva Trading House of Motorcycles, Inc. and Eastworld Motor Industries Corporation, are willing, out of patriotism and love of country, to convey, by way of donation to the Local Government of Quezon City the motorized vehicles hereunder described;

WHEREAS, the Deed of Donation and Acceptance is an integral part of this resolution, attached as "Annex A".

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation and Acceptance of motorcycle units from Guanzon Merchandising Corporation, Minerva Trading House of Motorcycles, Inc. and Eastworld Motor Industries Corporation for the use of the city's intensified tax collection efforts.
