A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE TO DISTRIBUTE TWENTY (20) UNITS OF MOTORCYCLES TO QUEZON CITY HALL EMPLOYEES AS RAFFLE PRIZES DURING THE QUEZON CITY HALL EMPLOYEES CHRISTMAS PARTY, AND TO TRANSFER ITS OWNERSHIP TO THE RECIPIENTS (LUCKY WINNER/S) QUEZON CITY HALL EMPLOYEE/S WITHOUT COST, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

Transfer of ownership from the Quezon City Government to the lucky winner/s shall be facilitated by the said lucky winner/s in coordination with the CGSD, subject to existing laws, rules and regulations.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte to distribute twenty (20) units of motorcycles to Quezon City Hall Employees as raffle prizes during the Quezon City Hall Employees Christmas Party, and to transfer its ownership to the recipients (lucky winner/s) Quezon City Hall Employee/S without cost, subject to existing laws, rules and regulations.

RESOLVED, FURTHER, that a copy of the approved Resolution shall form part of the documentary requirements for the transfer of ownership of the subject motorcycles.
