
RESOLUTION NO. SP- **9103**, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, ON BEHALF OF THE QUEZON CITY GOVERNMENT, TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF FOUR MILLION NINE HUNDRED THIRTY-NINE THOUSAND SIX HUNDRED FIFTY-TWO PESOS (PHP4,939,652.00), TO FUND THE PROJECTS AND ACTIVITIES OF THE QUEZON CITY PUBLIC SCHOOL TEACHERS ASSOCIATION (QCPSTA) FOR THE YEAR 2022, TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, AIDS, AND SUBSIDIES UNDER THE OFFICE OF THE CITY MAYOR IN THE 2022 ANNUAL BUDGET OF QUEZON CITY, OR FROM ANY AVAILABLE FUNDS.

WHEREAS, the QCPSTA is the official and duly recognized organization of teachers and non-teaching personnel under the Schools Division Office of Quezon City (SDO-QC). It is recognized by the Philippine Public School Teachers Association as their local affiliated chapter, and is also an affiliated chapter of the Alliance of Concerned Teachers (ACT);

WHEREAS, the QCPSTA has Sixteen Thousand (16,000) members, composed of teaching and non-teaching personnel, and covering a total of one hundred forty-three (143) member schools, ninety-seven (97) elementary schools, and forty-six (46) high schools;



WHEREAS, the declared principles and objectives of the QCPSTA is to promote the rights and welfare of public school teachers and employees, to be able to work for an educational system that contributes to the realization of a just, free, democratic, peaceful, and prosperous Philippines;

WHEREAS, among the proposed 2022 activities of the QCPSTA include the Annual Medical Check-up for its members, Annual Leadership Training, Continuing Teachers Education, Education Sector Consultation or the "2022 Sanggunian Para sa Edukasyon," Labor Day Celebration, and its newsletter publication;

WHEREAS, the QCPSTA, with its various welfare, training, and advocacy programs, are important partners of the City Government in supporting teachers and employees, and ensuring quality education in the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, on behalf of the Quezon City Government, to extend financial assistance in the amount of Four Million Nine Hundred Thirty-Nine Thousand Six Hundred Fifty-Two Pesos (Php4,939,652.00), to fund the projects and activities of the Quezon City Public School Teachers Association (QCPSTA) for the year 2022, to be taken from the appropriation for grants, aids, and subsidies under the Office of the City Mayor in the 2022 Annual Budget of Quezon City, or from any available funds.
