RESOLUTION NO. SP- 9113, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPS PHILIPPINES, INC., REPRESENTED BY ITS CUSTOMER SERVICE LEADER, MS. ANA LORRAINE GATCHALIAN JONES, FOR THE RELEASE OF EIGHT MILLION FIVE HUNDRED THIRTY-TWO THOUSAND TWO HUNDRED THIRTY-EIGHT PESOS (PHP8,532,238.00) ALLOTTED FOR THE MAINTENANCE SERVICES OF THE MACHINERIES AND EQUIPMENT OF THE QUEZON CITY GENERAL HOSPITAL COVERING THE PERIOD FROM JANUARY 01, 2020 TO DECEMBER 17, 2020.

WHEREAS, in order to promote the interest of the community and the City, the Quezon City Government and the Quezon City General Hospital (QCGH) deemed it proper to have a service provider for the maintenance of the machineries and equipment of the Quezon City General Hospital;

WHEREAS, Philips Philippines, Inc., a corporation duly recognized and existing under the laws of the Philippines with principal place of business at 10th Floor, Sun Life Center, 5th Avenue corner Rizal Drive, Bonifacio Global City, Taguig City, has knowledge of and licenses for providing innovative solutions in diagnosis, screening, treatment, health management and monitoring in cardiology, oncology, critical care and women's health, and is represented by its Customer Service Leader, Ms. Ana Lorraine Gatchalian Jones;

WHEREAS, Philips Philippines, Inc. provided QCGH with maintenance services, more specifically, Preventive Maintenance and Corrective Maintenance of the QCGH's Machineries and Equipment;

WHEREAS, the Quezon City General Hospital fully acknowledge the maintenance services rendered by Philips Philippines, Inc., from January 01, 2020 to December 17, 2020, with the total cost amounting to Eight Million Five Hundred Thirty-Two Thousand Two Hundred Thirty-Eight Pesos (Php8,532,238.00);

WHEREAS, the Quezon City Government has appropriated the said amount in the 2022 Supplemental Budget of the Quezon City General Hospital for the payment of the maintenance services rendered by Philips Philippines, Inc.;

WHEREAS, an appropriate authorization from the Quezon City Council is necessary for the release of the amount allocated for the payment of the services rendered by Philips Philippines, Inc.;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
