A RESOLUTION AUTHORIZING THE HOSPITAL DIRECTOR OF THE QUEZON CITY GENERAL HOSPITAL TO CLOSE AND TRANSFER THE UNEXPENDED BALANCE OF THE STA. LUCIA ANNEX HOSPITAL (SLAH) - CURRENT ACCOUNT WITH LANDBANK OF THE PHILIPPINES TO THE GENERAL FUND CURRENT ACCOUNT OF THE QUEZON CITY GENERAL HOSPITAL.

WHEREAS, Ordinance No. SP-634 S-98, entitled "An Ordinance Converting the Two-Storey Multi-Purpose Building Located at Sta. Lucia Avenue Sitio 5, Barangay Sta. Lucia, Quezon City, Into A Quezon City General Hospital - Sta. Lucia Annex Hospital" effectively transferred the administration of Quezon City General Hospital, Sta. Lucia Annex Hospital to Quezon City General Hospital (QCGH);

WHEREAS, the Quezon City General Hospital (QCGH) had managed the operations of QCGH Sta. Lucia Annex Hospital in the past, until it became a Health Center and the administration of QCGH Sta. Lucia Annex Hospital was transferred to the Quezon City Government until it ceased its operation to be a satellite hospital of the QCGH; 9

WHEREAS, the QCGH received an Audit Observation Memorandum No. 2021-005 from the Commission on Audit dated February 19, 2021 which states that:

"The unexpended balance of allotment in the amount of P10.512 million released to Sta. Lucia Annex Hospital (SLAH) was not reverted to the General Fund contrary to Article 418 of the Implementing Rules and Regulations of Republic Act (R.A.) No. 7160, thus, depriving the City constituents of the benefits to be derived therefrom."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Hospital Director of the Quezon City General Hospital to close and transfer the unexpended balance of the Sta. Lucia Annex Hospital (SLAH) - Current Account with Landbank of the Philippines to the General Fund Current Account of the Quezon City General Hospital.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Hospital Director of Quezon City General Hospital, for information and guidance.
