**Whereas**, *Sangguniang Bayan* Resolution No 055-2013 of Baler, Aurora established the sisterhood relationship agreement and friendship affiliation between the Municipality of Baler and the Quezon City Government;

**Whereas**, by virtue of *Sangguniang Panlungsod* Resolution No SP5855, S-2014 of the Quezon City Government, accepted and approved the earnest desire of the Municipality of Baler, Aurora for the sisterhood relationship agreement and friendship affiliation;

**Whereas**, to foster the historical and cultural ties of the between the Quezon City and the Municipality of Baler, Aurora and to encourage mutual understanding, friendship and peace through tourism, cultural history, environmental protection, health and sanitation, science and technology, urban planning and development, commerce/trade and industry, education, sports development, social service and good governance that will greatly benefit both Local Government Units;

**Section 2.** The parties shall have the following responsibilities, *to wit*:


- 2.1** Foster economic agreement between the local government units of Quezon City and Baler, Aurora on business enterprises;


