RESOLUTION

URGING THE CITY MAYOR TO INITIATE EXPLORATORY EF-FORT TOWARDS THE POSSIBLE FORGING OF A SISTER CITY RELATIONSHIP WITH NEW WESTMINSTER, BRITISH CCLUMBIA, CANADA IN RESPONSE TO THE CLAMOR OF SOME FILIPINO ORGANIZATIONS IN CANADA.

Canada and that City's Mayor, the Honorable Betty Toporowski;

WHEREAS, hundred of Filipinos are in that Royal City of New Wesminster either as immigrants of permanent status or as immigrant workers;

WHEREAS, the possible establishment of Sister City relationship between the two (2) cities would promote and enhance their cooperation, partnership and valuable exchanges of information and technology in the areas of education, culture, tourism, business, science and other fileds of mutual concern;

NOW, THEREFORE,
