ORDINANCE

APPROVING SUPPLEMENTAL BUDGET NO. 5 UNDER THE GENERAL FUND INVOLVING THE SUM OF THIRTEEN MILLION TWO HUNDRED TWENTY THOUSAND PESOS (P13,220,000.00), AND SUPPLEMENTAL BUDGET NO. 4 UNDER THE INFRASTRUCTURE FUND INVOLVING THE SUM OF ONE MILLION TWO HUNDRED SIXTY THOUSAND PESOS (P1,260,000.00) TO COVER THE PAYMENT OF THE YEAR-END BONUS AND ADDITIONAL COST OF LIVING ALLOWANCE OF QUEZON CITY OFFICIALS AND EMPLOYEES; AND PROVIDING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Quezon City
in session assembled:

Section 1. Supplemental Budget No. 5 under the
General Fund for the Calendar Year 1988 providing for
the payment of the year-end bonus and the additional
cost of living allowance to Quezon City Officials and
employees is hereby approved, the document explaining
the expenditures is being attached herewith and is
hereby made an integral part of this ordinance.

Section 2. Supplemental Budget No. 4 under the
Infrastructure Fund for the Calendar Year 1988 providing
for the payment of the year-end bonus and the cost of
living allowance of officials and employees is hereby
approved, the document explaining the expenditures is
being attached herewith and is hereby made an integral
part of this ordinance.

Section 3. The National Government Guidelines are
hereby adopted to govern the payment of the year-end
bonus provided for in Section One and Section Two hereof;
PROVIDED, that the year-end bonus shall be paid in full
