## Ordinance No. NC-70, S-88

ORDINANCE
APPROVING SUPPLEMENTAL BUDGET NO. 6 UNDER THE GENERAL
FUND INVOLVING THE SUM OF SEVENTEEN MILLION FOUR HUNDRED SIXTY-FOUR THOUSAND NINE HUNDRED THIRTY-EIGHT
PESOS (\$\frac{P}17,464,938.00)\$ AND SUPPLEMENTAL BUDGET NO. 5
UNDER THE INFRASTRUCTURE FUND INVOLVING THE SUM OF TWO
MILLION SIX HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED
EIGHTY-FIVE PESOS (\$\frac{P}2,615,785.00)\$ TO COVER THE VARIOUS
EXPENSES OF THE CITY GOVERNMENT; AND PROVIDING THE
NECESSARY FUNDS THEREFOR.

Introduced by the Committee on Appropriations. Sponsored by the Committee on Ways and Means and the Committee on Laws, Rules and Internal Government.

Be it ordained by the City Council of Quezon City in session assembled:

Section 1. Supplemental Budget No. 6 of the Calendar Year 1988 under the General Fund involving the sum of SEVENTEEN MILLION FOUR HUNDRED SIXTY-FOUR THOU-SAND NINE HUNDRED THIRTY-EIGHT PESOS (P17,464,938.00) to cover the various expenses of the City Government is hereby approved, the document explaining the expenditures is being attached herewith and is hereby made an integral part of this ordinance.

Section 2. Supplemental Budget No. 5 for the Calendar Year 1988 under the Infrastructure Fund involving the sum of TWO MILLION SIX HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED EIGHTY-FIVE PESOS (\$\frac{p}{2}\,615\,785\.00\) to cover the various expenses of the City Government is hereby approved, the document explaining the expenditures is being attached herewith and is hereby made an integral part of this ordinance.

Section 3. There are hereby appropriated from the General Fund the sum of SEVENTEEN MILLION FOUR HUNDRED SIXTY FOUR THOUSAND NINE HUNDRED THIRTY EIGHT PESOS (P17,464,938.00) and from the Infrastructure Fund the sum of TWO MILLION SIX HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED EIGHTY-FIVE PESOS (P2,615,785.00), or so much thereof as may be necessary, to be made available to cover the expenses provided for in Section One and Section Two hereof.

Section 4. The appropriations for various items of expenditures contained in the attached list, provided for and covered by Supplemental Budget No. 4, General Fund, are hereby withdrawn.
