BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby appropriated the sum of Forty Six Million Six Hundred Thirty Seven Thousand Pesos (P46,637,000.00) to be made available for the payment of the Personnel Economic Relief Allowance (PERA) of employees of the Quezon City Government effective January 1, 1991, the amount to be taken from Internal Revenue Allotment, Specific Tax Allotment and Local Government Revenue Stabilization Fund in the CY-1991 General Appropriations Act and from any other available funds; Provided, that the payment of the PERA shall be in accordance with the guidelines embodied under Budget and Management, subject to the availability of funds.
